By 1789 James owned three parcels of land totaling 398 acres. It appears that he sold 262 acres (two of the parcels) to Thomas Mountjoy by 1791 but the 1792 tax records show some confusion on the 142 acre parcel with taxes being paid by both Thomas Mountjoy and James. Without the sale or purchase deeds it's hard to understand who owned what by 1792. As a reference point James purchased 136 acres from Isaac Green in September of 1786 but the tax records don't reflect a change of ownership until 1788, two years later. It's possible that Thomas Mountjoy purchased James's land as early as 1790 based on this delay in reporting tax records.

It's possible that this sale of land is also tied to the reduction of James's property (see tithables list for James) observed in 1788. Could James have had financial problems in the late 1780s causing both the reduction in property and the need for sale of some of his land? Could he have been preparing to move to Maryland as early as 1790? We don't know quite when he did move but it was after 1792 and before 1815 – what brought on the move?

Need to look for Green name on earlier property and look for Mountjoy entries to tie down some of the sale dates
