RESEARCH OBJECTIVE

Who was husband of Barbary ([-?-]) Calor of Loudoun County, Virginia and who were her children?

ITEMIZED RESEARCH RESULTS

This is a listing of all documented evidence of Barbary ([-?-]) Calor in Loudon County (or anywhere else as of this date – Nov 2007). One group of records that I've not yet fully examined is the court orders from Loudoun County.

Notes:

Does not appear in wills of 1757-1841.

Does not appear in deed books 1757-1810.

Does not appear in Loudoun militia records which start in 1793.

Personal property tax and land tax lists were collected in the period Mar-Jun of the tax year although some returns were not made until later in the fall. The tax assessment was payable in Nov.

5	1785	Barbra Calor appeared as head of household along with Nichlass Calor in the Loudoun County tithables list, Cameron Parish, Wm Stanhope's district. ⁵	
6	1786	Widow Kallar appeared as head of household along with Nicholas Kallar in the Loudoun County tithables list, Cameron Parish, James Jenings' district. ⁶	
7	11 Apr 1787	Barbary Calor appeared in the Loudoun County personal property tax lists, 2 nd Battalion, with one white male tithable 16-12, two horses and three cows. ⁷	
8	18 May 1787	Barbary Calor, administrator of the estate of Jacob Calor, was awarded 11 pounds, 10 shillings and interest thereon dating from 1 Dec 1783. Barbary was the plaintiff against Daniel Moxley and Daniel Reagan.8	
9	12 May 1788	Barbary Calor appeared in the Loudoun County personal property tax lists, 2 nd Battalion, with two white male tithables 16-21 and two horses. ⁹	Ö/
10	17 Jul 1789	Barbara Caylor appeared in the Loudoun County personal property tax lists, 2 nd Battalion, with Nicholas Caylor as her one tithable and three horses. ¹⁰	
11	17 Jun 1790	Barbara Calor appeared in the Loudoun County personal property tax lists, 2 nd Battalion, with Nicolas Caylor as her one tithable and four horses. ¹¹	
12	12 Jun 1791	Barbara Caylor appeared in the Loudoun County personal property tax lists, 2 nd Battalion, with Nicolas Caylor as her one tithable and four horses. ¹²

13	1792	Barbara Caylor appeared in the Loudoun County personal property tax lists, 2 nd Battalion, with Nicolas Caylor as her one tithable and two horses. ¹³	
14	Aug 1795	Barbary Calor appeared in the Loudoun County personal property tax lists, 2 nd Battalion, with Adam Calor listed as a white male tithable over 16, and three horses. ¹⁴	
15	13 Oct 1796	Barbary Caler appeared in the Loudoun County personal property tax lists, 2 nd Battalion, with one tithable and three horses. ¹⁵	The one tithable was not named.
16	1806	She continued to appear in the land tax lists after 1783 with her last listing in 1806 – same property although by this time the property was that of George Lee. 16,17	
17	1807	Barbary did not appear in the 1807 list but her property appeared in the listing for G Lee's executors "of Barbara Calor" for 114 acres. ¹⁸	
18	1809	The same listing as in 1807 appeared in the 1809 land tax lists – there were no taxes collected in 1808. ¹⁹	7/
19	1810	There was no reference to Barbary Calor in the 1810 list for George Lee – the acreage appeared as his property with no note. ²⁰	

ANALYSIS OF ITEMIZED RESULTS

Barbary's family appears to consist of husband Jacob Calor and the following sons:

Andrew b. Apr 1762 d. late 1802 (after April)

Nicholas b. 1764-5 d. late 1792

Jacob b. Dec 1775 – Apr 1776 d. Jun 1848

Adam b. Jul 1776 d. 1840-1

See the individual research reports on each of these family members for more details. Both Jacob and Adam made their first appearance on the personal property tax list in 1795. This, along with the other information suggests they could have been twins.

We can estimate Barbary's birth year from this information. Say Barbary was age 41, at the end of her child-bearing years, with her youngest son Adam (or Jacob and Adam) – that would place her birth after 1735. Further, say she was at least 21 at the birth of her oldest known child Andrew – that would place her birth before 1741. So, Barbary was likely born 1734-1741. She disappeared from Loudoun records by 1807, at age 66-73. It's a reasonable conclusion to say she likely died about 1807. This is approximately coincident with the time (1805-6) that Adam disappeared from Loudoun records and then showed up in Ohio.
