20 June 1787

Dateline Philadelphia, June 11th: On Saturday last a gentleman arrived in this city from Fort Pitt and informs that about the 18th ult. as Caleb Lane, John Williams, Samuel Robinson and Daniel Wright were going down the Ohio to Kentucke, they went on shore on the west side of the river and were immediately surrounded by a party of Indians who fired on and killed two of them [not named] and took the other two prisoners, and made off. Two of the young men [not named] were inhabitants of New Jersey while the other two, it is supposed, belong to the State of New York.

27 June 1787

The creditors of Solomon Vanderbeck, insolvent debtor, of New Barbadoes, now confined in the Bergen County goal, are to appear before judges of the Court of Common Pleas on 6th August at the house of Morris Earl, innkeeper at Hackinsack, to show cause why an assignment of his estate should not be made and he discharged

from confinement.

John Simpson Jr., executor, adv. for sale on August 6th one half part of a grist mill, formerly property of John Simpson, deceased, situate about one mile from Turkey meeting house in Essex County. Also, a good house with a tradesman's shop adjoining and three acres with a young orchard.

11 July 1787

The creditors of David Pierson and Barne Ogden, Newark, are to appear before the Essex County Court of Common Pleas to show cause why they should not be released from confinement.

William Holmes, Crane Town, adv. for sale a wide variety of goods and wares at his store.

Also, an act to release Henry Denny, of Bergen County, from the payment of the sale [price] of the forfeited plantation of Michael Van Tuyle.

18 July 1787

William Pell, Newark, adv. that all persons indebted to the late Tavern of Samuel Smith from 14 June to 24 October 1786 are desired to make immediate payment as he is determined to finally close his affairs with Mr. Smith in three weeks time.

1st August 1787

John Chandler Jr., Elizabeth Town, adv. for a runaway apprentice Cornelius Marrs, about 19, five feet high.

Albert Van Voorhies adv. that he intends to apply to the New Jersey Supreme Court to remedy the loss of his deeds to a farm of 48 and a half acres whereon he resides in New Barbadoes, Bergen County.

15 August 1787

Richard Deane at the North River in New York adv. for sale the best New York rum, shrub and geneva.

Benjamin Hayes, Elizabeth Town, adv. for a strayed cow.

22 August 1787
